



Golf Cart Contract

1. All Golf carts must be registered and have a current year campground sticker displayed on the cart at all times. \$20 Fee/year
2. All Drivers must be 16 years old and possess a valid driver's license or be with a responsible adult at least 25 years old with a valid license.
3. Speed limit is a maximum of 10 KPH for Golf Carts at all times.
4. No Golf Carts are to be driven in the campground after 11 PM or before 9 AM.
5. Only 1 Golf cart per site allowed. No exceptions.
6. Nature trails or River paths can be very dangerous and cause serious injury, they are not recommended for Golf cart use.
7. The laws for motor vehicles apply to Golf carts as they are considered a motor vehicle i.e. impairment, speeding etc.
8. The registered owner of the Golf Cart is responsible for any and all drivers and infractions of the rules at all times.
9. Riverbend Campground will in no way be held liable or responsible for any damage or injuries caused by Cart or Driver.
10. All Golf Carts must be kept in good running order, quiet and good repair at all times.
11. Golf Carts must be used for a purpose, no unnecessary driving, so please be considerate when driving in the campground.
12. Failure for not following the above rules may cause loss of temporary or permanent privileges.

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.

BY SIGNING THIS RELEASE AGREEMENT YOU WILL WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION FOLLOWING AN ACCIDENT

Riverbend Campground and their Directors, officers, employees, agents, independent contractors, subcontractors, representatives, organizers, and volunteers will be referred to as the RELEASEES. In this release Agreement the term Activities shall include all activities, events, services or use of facilities provided and all equipment and property of Riverbend Campground and any private activities or vehicles, golf carts the campers engaging in.

Assumption of Risk: I am aware that participating in the Activities involves many inherent risk, dangers and hazards, including but not limited to changing weather conditions, natural objects, impact collision with persons property. I am aware that none of the Risks, Dangers and Hazards of the activities is negligence on part of the Releasees, including the failure of the releases to safeguard or protect me from the risks, dangers and hazards of the activities, some of which are referred to above. **I freely accept and fully assume all such risks, and Hazards of the activities and the possibility of personal injury, death, property damage or loss resulting therefrom.**

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE ACTIVITIES AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGER AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH PROPERTY DAMAGE AND LOSS.

TO WAIVE ANY AND ALL CLAIMS THAT I HAVE OR MAY IN THE FUTURE HAVE AGAINST THE RELEASEES FROM ANY AND ALL LIABILITY THAT I MAY SUFFER OR THAT MY NEXT OF KIN MAY SUFFER AS A RESULT OF THE ACTIVITIES AT RIVERBEND CAMPGROUND IN THE PROVINCE OF ALBERTA
