



Paddle Boat Rules and Liability Waiver

There is no life guards on duty, Use boats at your own risk

Everyone on the paddle boats must use life jackets at all time including getting on boats and exiting.

No more than 4 people on paddle boats. YOU ARE RESPONSIBLE FOR ANY AND ALL DAMAGE

You as the guardian must watch all youths you are responsible for under the age of 18

Must stay in boats when leaving dock, no jumping in or out. NO UNSAFE BEHAVIOR

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.

BY SIGNING THIS RELEASE AGREEMENT YOU WILL WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION FOLLOWING AN ACCIDENT

Riverbend Campground and their Directors, officers, employees, agents, independent contractors, subcontractors, representatives, organizers, and volunteers will be referred to as the RELEASEES.

In this release Agreement the term Activities shall include all activities, events, services or use of facilities provided and all equipment and property of Riverbend Campground.

Assumption of Risk: I am aware that participating in the Activities involves many inherent risk, dangers and hazards, including but not limited to changing weather conditions, natural objects, impact collision with persons property. I am aware that none of the Risks, Dangers and Hazards of the activities is negligence on part of the Releasees, including the failure of the releasees to safeguard or protect me from the risks, dangers and hazards of the activities, some of which are referred to above. **I freely accept and fully assume all such risks, and Hazards of the activities and the possibility of personal injury, death, property damage or loss resulting therefrom.**

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE ACTIVITIES AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGER AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH PROPERTY DAMAGE AND LOSS.

TO WAIVE ANY AND ALL CLAIMS THAT I HAVE OR MAY IN THE FUTURE HAVE AGAINST THE RELEASEES FROM ANY AND ALL LIABILITY THAT I MAY SUFFER OR THAT MY NEXT OF KIN MAY SUFFER AS A RESULT OF THE ACTIVITIES AT RIVERBEND CAMPGROUND IN THE PROVINCE OF ALBERTA
